# **International Human Rights Tribunals**

There is no one place containing all information and resources on and by the int'l human rights tribunals and bodies. It helps to know the issuing body and the context before embarking on a research quest. Keep in mind the role of the IGOs such as the United Nations and NGOs, non-for-profit organizations and associations, and the role of individual States and the corresponding domestic laws on the subject.
